A skilled, competent workforce is vital for meeting the challenge of an increasingly competitive global economy. With legal and environmental drivers pushing to more sophisticated waste management solutions, it is crucial to facilitate an adequate supply of competent people to develop, maintain and enhance the waste management industry.

The industry is undergoing a substantial period of change and based on widespread agreement on the trend towards the use of more advanced technologies and automation of processes, it has been estimated that a significant additional number of people will be employed in the industry at all levels.

The waste management industry is perceived to have a poor image and this has affected the recruitment drive in the past. The need to attract young people is widely recognised as the industry workforce ages and employees with a wealth of experience approach retirement.

The Apprenticeship in Sustainable Resource Management is open to individuals of any age and does not impose any restrictions to entry. The employer must be confident that the apprentice has the learning potential/capacity, motivation and aptitude to achieve the framework.

There are varying pathways for apprenticeships within sustainable resource management qualification. Learners can choose the general, collection, reception/segregation, processing, wee (white goods) or the re-use pathway route.

What is an Apprenticeship?

An apprenticeship is a way for young people and adult learners alike to earn while they learn in employment, while gaining a vocational qualification and a real future. Hiring apprentices or training existing staff will help your business to grow your own talent by developing a motivated, skilled and qualified workforce.

An apprenticeship is a programme of learning and qualifications, completed in the workplace that provides employees with the skills, knowledge, confidence and competencies they need to progress in their chosen career or industry.

We believe the key to apprenticeships is providing high quality training that will benefit both apprentices and employers in the workplace.

Where do they take place?

Most of the training is 'on the job' within the workplace. To achieve an apprenticeship, employees will need to build a portfolio of evidence via an e-portfolio system which shows that they are competent.

Our Training Officers will visit on a regular basis and carry out assessments while your employee, carries out their routine tasks at work. All work produced will be signposted so that employers data will be fully protected. There will also be a knowledge element to all apprenticeships which can be generated through assessment, written questions or can be recorded digitally.

Who are they for?

Apprenticeships are available whether you are being employed as an apprentice in a new job or as part of training at your existing workplace. These programmes are part funded by the European Social Fund through the Welsh Government.

Level 2 Foundation Apprenticeship in Sustainable Recycling Activities

This qualification is intended for those who are involved in recycling activities (waste management). You will have a choice of optional units covering different waste management activities such;

- as collect recyclables and other materials
- sort and prepare recyclables and other materials
- manual handling
- select and use containers for recyclables and other materials

To achieve the diploma, learners must attain a minimum of 37 credits in total. Learners must complete all five mandatory units (22 credits) and another 5 optional units (minimum 15 credits).

Level 3 Apprenticeship in Sustainable Recycling Activities

The structure of the qualification has been designed to enable complete flexibility across the sustainable recycling roles at a team leader/supervisory level. The qualification is also part of the Level 3 Sustainable Resource Management Apprenticeship. Achievement of this qualification demonstrates competence by the learner to operate appropriately and in accordance with employment requirements whilst undertaking a supervisory role.

To achieve the full Diploma the learner must attain a minimum of 46 credits in total. Learners must complete all six mandatory units (35 credits) and at least two units from Group B (7 credits) and one unit from Group C (4 credits).

What is the Operator Competence Scheme?

The operator competence scheme (sometimes known as a “WAMITAB” or CoTC) is created to allow permitted waste facilities in England & Wales to indicate they employ technically competent people with the right skills & knowledge to ensure waste sites are complying with Environmental Permitting Regulations (2007).

Why do I need to complete this Scheme?

The CIWM/WAMITAB Operator Competence Scheme was approved by Defra and the Welsh Government for England & Wales in 2008. Participation in the scheme delivers evidence of the technical knowledge needed on a waste site and can be required by employers based in the waste industry.

COURSE DETAILS

Duration

This course is assessed in the workplace and may take from 4 months to 12 months to complete depending on individual & site requirements.

SHEA Training Scheme (Waste & Recycling)

The SHEA Passport that is also known as the Safety Health and Environmental Awareness Scheme, was developed by the Energy & Utilities Skills Register (EUSR) in partnership with the recycling and waste industry.

The passport scheme is designed for people who require access to operational sites, both permanent and temporary, including all levels of staff such as; operatives, supervisors and management in the Waste & recycling industry.

It is designed to provide on-site evidence that an individual has demonstrated an appropriate level of knowledge and awareness to health, safety and environmental awareness.

Achieving a SHEA (Waste Management) Passport card takes one day of training and lasts for three years from the date of issue.

Accreditation

After successful completion of this scheme individuals will be registered on the Energy & Utility Skills register (EUSR) database and will receive a photo card.

The SHEA (waste management) Scheme is also affiliated with the nationally recognised Construction Skills Certification Scheme (CSCS).

COURSE STRUCTURE

This one day course consists of eight standard modules that are applicable across the utilities industries and also include two that are specific to the waste and recycling industry. Individuals are encouraged on this course to use their experience & knowledge of workplace health, safety and environmental issues. Brief presentations for each module are followed by a short multiple choice assessment paper. The assessment pass mark for these papers are 80%.

Getting your EUSR card

After successful completion this training we will issue you with a cover note and register you with EUSR. The SHEA (waste management) card will be issued within 28 days.
