



This qualification develops the knowledge and understanding underpinning work in a broad range of job roles within the waste and resource management industry. This qualification is perfect for existing employees or apprentices that need to understand the underlying principles of sustainable resource management to ensure services are delivered safely, efficiently and to a high standard. This qualification will support career progression from operative to team leader/supervisory level occupation within the waste and resource management industry.

The WAMITAB Level 3 Certificate in Principles of Sustainable Resource Managements a flexible qualification that can be tailored to meet the requirements of specific job roles in the sector or within a particular organisation – these job roles include:

- Refuse collection supervisor
- Treatment supervisor
- Transfer station supervisor
- Landfill supervisor
- Sustainability officer
- Materials recycling facility supervisor

People already working in relevant roles could be employed by local authorities, waste management companies or third sector (not-for-profit) organisations. This qualification will support the sector to overcome significant skills gaps as more than two-thirds (69%) of the workforce holds a Level 2 as their highest qualifications (UKCES, 2012).



Course Delivery

To achieve this qualification, learners must complete all mandatory units which are designed to ensure learners understand the principles of waste and recycling, identify and classify waste correctly, recognise the importance of environmental protection and can maintain health and safety in the workplace.

- Learners who choose the General Pathway will complete units covering topics such as policy, legislation, environmental permitting, systems and technologies used in resource management.
- Learners who choose the Reuse Pathway will complete units covering the refurbishment, reuse and transportation of materials in a retail environment. This pathway is used primarily for those seeking employment, or working within the third (not-for-profit) sector; for instance, in charity shops.

Assessment and training will take place in the workplace and you will be supported by a training officer who has industry experience. Your training officer will visit you once per month for up to two hours and you will be given work to complete before your next assessment.

You will have an online e-portfolio which you will use to gather evidence. Work based assessments and observations will be carried out and you will be expected to produce products of work to demonstrate your competence.

Entry Requirements

If an apprentice has not already achieved Level 2 English and Maths they are expected to study for them and take the tests via our Essential skills program, which will develop and ultimately demonstrate the apprentices' ability to use Commication and Application of Number.

Employers see these skills as essential, and by holding this qualification apprentices are showing they have the ability to apply them in work situations.

To achieve this qualification, learners who choose the General Pathway must complete all Mandatory Units, plus learners must complete 7 units from Optional Group B and in doing so ensure that at least six of them are at Level 3.

To achieve this qualification, learners who choose the Reuse Pathway must complete all Mandatory Units, plus all Reuse Mandatory Group units. Learners must then complete one unit from Reuse Option Group A unless you select CK3 or CK2 in which case you must select another unit from this group, two units from Reuse Option Group B and a further unit from Reuse Option Group C.
